You may make reasonable improvements to the building, but in the event the building is returned, no allowances will be given for the improvements.

What Buildings Are Allowed?

- 8 x 8 to 10 x 16 Organizer buildings (6' or 7' sidewalls only)
- Gable entry buildings only.
- Customer is responsible for painting and caulking the building
- Basic options, such as windows, and shelving may be added. (may require a larger down payment)
- Lean to, or attached structures are not allowed
- Radiant barrier will be included on all RTON buildings
- ALL BUILDINGS INCLUDE FULL TREATED FLOOR SYSTEM



Which Deliveries are Not Allowed?

- Behind a fence unless there is a 10' or more opening in the gate
- Where a neighbor's or public property must be crossed. Although your current neighbor may agree, situations and neighbors change.
- Where septic lines are crossed over
- There must be adequate room to get into your yard and maneuver the shed for proper placement, without removal or damage to any existing structures

What if my building does not meet requirements?

- We have traditional financing available for any style, any size, any options, where the building can be built on site. Reasonable rates.

What You Will Need To Complete the Agreement

- Driver's License
- Signed landlord waiver if you do not own the property (a blank landlord waiver is available on our website)
- Social Security number (personal verification only)
- Employer name and phone number if not retired
- 3 personal contacts (include name, city, phone # & relationship to be used only if you cannot be reached)
- Your primary telephone number and an alternate number
- 2 months' payments (down payment is first & last month's payment)
- You or an authorized person must sign the delivery receipt when the building is complete.
